#### **WSD Goals**

### Goal #1: Increase student learning and growth

- We have received our NECAP scores and are in the process of disaggregating the data. We are also looking at the data to see how we can improve our instruction. This will be the last time we receive NECAP scores as we are moving to the SBAC. While we need to look at the data, we must also begin to focus on what we will be asked to do on the SBAC. We need to begin to prepare our students for this assessment, which I believe, will look very different than the NECAP.
- Our STARS have earned 100,000 stars and had their big school-wide celebration on Friday, Feb. 7th. The students had the opportunity to hear A2VT perform for them. This performance was made possible through the support of the PTO who funded the event.
- Last month we reported about the intentional focus on supporting students
  to be on time to school. Kate, Leon, Karen, and Emmy have devoted a
  tremendous amount of time working with students to understand the
  importance of this expected behavior, identify what's getting in the way of
  meeting this expectation, and finding strategies that empower the student
  to consistently be on time. There has been tremendous progress as you
  can see from the chart below:

 The test window for the 2014 WIDA ACCESS for English Language Learners will open on Monday February 24, and close on Friday, April 11, 2014. We are required to evaluate all school age ELLs enrolled in K-12 through this assessment.

## Goal #2: Increase student engagement through best instructional practices

- We had our studio math days this week with Clare Earley. Clare, Glenn Willette and Mary O'Rourke spent the first ½ day collecting data. They visited the participating teachers' classrooms (5 teachers) and looked for math best practices. Clare then worked with Stefanie Hamble, our studio teacher on the lesson she would teach the next day. On day two, we observed in Stefanie's room and spent the afternoon debriefing. These two days were very powerful professional development days. They help determine the next steps as we move forward with best practices in mathematics. Glenn's role as a math coach helps all teachers with these best practices and not just the 5 teachers that are participating.
- We were fortunate to have Soryu visit us last week. Soryu is the voice the children hear during the mindfulness activity each day. Soryu met with the entire elementary school for 30 minutes. Students were impressive as they shared their experiences with mindfulness in front of the whole elementary. After the school assembly, he visited with several classrooms. This was an exciting day for the students. They believe he is a star because they see him on the smartboard, just like tv to them!
- Middle and high school students designing learning through the iLab shared their projects with staff and students on January 23. This was the first opportunity this year for personalized, proficiency-based work to be shared school-wide, and it was an exciting, positive event. Later in May the seniors will share their Senior Projects with the school community, highlighting one of our great traditions.
- The Young Writers Project (YWP) is beginning an exciting workshop to enrich the writing experience for a group of our middle school students this month. Two of our middle school teachers are also partnering with this organization and using their online resources in the humanities classrooms. Students are highly engaged and proud of their work.
- Seven high school students, members of the OVX club (Our Voices Exposed) were invited to speak before the Vermont Legislature on January 21 about the dangers of secondhand smoke in vehicles. Our students spoke articulately before the legislators as they were considering bill #878. Channel 5 News had a great video clip of our students in action. Our students and advisor Cheryl Brosnan represented our school community very well!
- Fifteen educators have signed up to take an 8-week class held after school with ELL teacher Kirsten Kollaard this semester. During this class the WIDA's "Can Do" philosophy will be shared with teachers and how to

- use this strength-based approach to best support ELLs. Kirsten will draw connections between the Common Core Standards and the WIDA standards.
- Dr. Karen Fondacaro, from Connecting Cultures at UVM, will return to Winooski on March 28th to continue work with ELL teachers, guidance counselors, liaisons, and social workers. The focus of the day will be to provide additional information on being trauma informed, as well as "hands on" strategies that can be used just 10 minutes a day with students. This includes skills which help children to regulate their emotions, build peer relationships, and learn problem solving strategies which help students gain confidence in themselves and better able to solve problems. This aligns with the work we are doing district-wide, and is supported by the Refugee Children's School Impact Grant.

# Goal #3: Increase parent/community engagement

 We had a very good PACTS meeting in January. We had about seven Nepali parents join us for the meeting. Our sub-committee discussed ways to be more inclusive and foster friendships outside of school. We will work on this at our next meeting. The goal being to have simple words translated that would allow parents to send quick invites to other parents that are in the language of the recipient. Also, we continue to research the possible purchase of translation equipment.

### Goal #4: Collaboration and communication

- As part of our Green Mountain Star plan, teachers are expected to send out weekly newsletters to parents. At our meeting on Monday, Feb. 3rd, each team shared examples of the newsletters they are sharing with families. Some grade levels send out a grade level newsletter, while other grade levels send them out individually and one teacher uses a blog. The goal is to have most of this done electronically for all of those that have access to computers and send paper copies to the families that do not have access to a computer. We are also looking at ways to get the information to our ELL families.

#### Finance

- As of January 31, 2014 our estimated fund balance for FY14 is \$ 66,453.
- The Reserve Account has a balance of \$ 664,513. An RFP will be going out to finish the last phase of the unit vent project.
- Our FY13 audit is complete and our fund balance is \$ 115,736.00. Article
  VI will ask the taxpayers to apply \$100,000 of the Fund Balance to the FY
  15 budget and the balance would go into the reserve account. The audit
  report is being written and will be available for the March meeting.
