We will begin to publicize this endeavor more frequently with families and the broader community moving forward. Our first public sharing of this project is on page 2 of the April District Newsletter article entitled "Beautiful Environments Create Beautiful Children"!

In December 2016, the board authorized the use of \$15K from the Capital Reserve Account to begin a feasibility study for possible expansion/remodel of the current campus building. We contracted with Joseph Architects, LLC to explore the areas for potential growth and they completed the initial study. As was reported earlier, we shifted gears in December 2017 and have partnered with TruexCullins for the remaining components of the project. To date we have nearly spent the \$15K through the following investments:

- Payments to Joseph Architects, LLC in FY17 \$5,467 and FY18 \$3,135
- Payments to TruexCullins, Inc in FY18 in \$6,311
 - o Total services paid from Capital Reserve Account \$14,914

In addition, we have made one payment to TruexCullins, Inc in FY18 for \$3,209, from the operating budget. We will be asking the board to approve up to \$20K from the Capital Reserve Account at the May meeting to complete a comprehensive facility evaluation component of the process.

Goal #1: College & Career Readiness

Finance/Operations

- At the end of April our fund balance for FY18 is favorably forecasted at \$28K or less than 1% of the voter-approved budget. The forecast includes assumptions for the health reimbursement accounts expenses.
- The budget for Health Reimbursement Arrangements (HRA) for FY18 is \$281,260. As of April 30, 2018, we have expended \$197K or 70% of the budget.
- The projected balance of the Reserve Fund is currently \$390K.
