# • WSD Capital Project Update:

- Due to the COVID-19 crisis and specifically, due to school dismissal, "stay at home, stay safe" order and supply chain unpredictability ReArch, truex Cullins, Tom Barden and WSD have agreed to modify the Phasing Plan. More details will come in May but this means ReArch will focus on new construction and site work from June 2020-June 2021 so there will be little to no disruption to the interior of the building for the 2020-21 school year.
- <u>Hiring</u>: The following positions are posted.
  - Elementary Teacher positions (2 FTE): Operating budget funded
  - WMHS Speech-Language Pathologist (1.0 FTE): Operating budget funded
  - Finance Manager (1 FTE): Operating budget funded
  - Director of Curriculum and Learning (1 FTE): Federal Grant funded
  - WMHS Math Coach (.5 FTE): Federal Grant funded
  - Community-Based Learning Coach (1.0 FTE): Barr Grant funded
- **Finance Manager:** Our Interim Finance Manager, George Cormier has decided that the position was not a good fit for him and has resigned. WSD did not incur any expenses for his week of work per mutual agreement. Former Finance Manager Rebecca Goulet has agreed to increase her involvement and has jumped right in working with members of our team to keep our financial system operating. We are confident that Rebecca's knowledge of our financial systems and operations coupled with her available weekly time will be adequate through June 30, 2020. We have several applications for the permanent position and will begin interviews later in April.

**WSD Goals:** Due to the organizational and leadership needs required by the COVID-19 pandemic I chose to forego this section of the report until May so the WSD Leadership Team can focus on the imminent planning, preparations and implementation of the directives of Governor Scott and Secretary of Education French.

### **Finance/Operations**

- At the end of March our fund balance for FY20 is favorably forecasted \$642K or 3.5% of the approved budget.
- The balance of the Capital Reserve Fund is currently \$322K. There are no outstanding obligations for this account.
- The budget for Health Reimbursement Arrangement (HRA) for FY20 is \$490K. We have expended \$256K or 52% of the budget with three months remaining.
- The Bond Anticipation Note (BAN) is available as a line of credit from the People's United Bank to support the capital project. Currently we have drawn \$1,953,000.
